


NPS ASKS FOR PADDLERS HELP: Prevent the Spread of Hydrilla in the Obed Wild and Scenic River

Hydrilla has been found in the Obed/Emory river system. Hydrilla (*Hydrilla verticillata*) is an aquatic, invasive plant which is adapted to grow in very low light and which is able to tolerate a wide range of temperatures and conditions. Growing rapidly (up to one inch per day), hydrilla can quickly dominate native vegetation. Hydrilla forms dense mats at the surface of the water and can dramatically alter the balance of an ecosystem. Hydrilla can affect water quality and flow patterns. The presence of hydrilla can also have significant impacts on fish. Hydrilla covers spawning areas, impedes predation and can ultimately lead to a decrease in sport-fish populations. Hydrilla can also cause significant reductions in oxygen levels which can negatively impact fish populations, and in extreme cases, result in fish kills. Hydrilla also limits human uses of streams. Hydrilla-choked channels can make swimming or fishing difficult or impossible—not to mention the fact that setting up for your roll in a thick mat of hydrilla will not be much fun!





Although the exact extent of the hydrilla infestation within the Obed/Emory system is not known at this time, field observations have identified hydrilla in Daddy's Creek between Antioch Bridge and the Devil's Breakfast Table, in Daddy's Creek below the Devil's Breakfast Table, in the Obed River below its confluence with Daddy's Creek, and in the Emory River below its confluence with the Obed.



WHAT YOU CAN DO: Humans are one of the main methods of transport for hydrilla. Even very small fragments or seeds which stick to boats, shoes, paddles or other equipment can lead to an explosion of hydrilla in a new segment of a stream or in another stream system. For example, if you paddle from Lilly Bridge to Nemo on one day, and then from Barnett Bridge to Jett Bridge on the next, there is a chance that you might unintentionally introduce hydrilla into Clear Creek. One of the best things that you can do to prevent this is to wash off your boat and all other equipment with river water at the take-out, insuring that all vegetative matter, mud, etc. have been removed. Also, try to avoid paddling or wading through hydrilla, and use special caution at the put-in and take-out and any time that you go to shore. Last Meeting Minutes

Matt Hudson, ranger at the NPS Obed Wild and Scenic River (OWSR), gave a two-part presentation on the park: the current status of land acquisition and emergency evacuation routes for whitewater paddlers.

Park Land Acquisition:

Park acquisitions can be to acquire to own or as a scenic or trail easement. Of the 5,195 acres within the park boundary, 2,674 acres are owned by the NPS and 1,081 acres have easements (987 scenic and 93 trail easements).

In 2006 key land on the Lower Clear Creek bluff line was purchased by a consortium of environmental, recreation, and conservation groups spearheaded by TCWP and including ETWC, Chota, ET Climbers Coalition, The Nature Conservancy, and TSRA. In 2008 the NPS acquired 43.7 acres near where Little Clear Creek comes in to Clear Creek. A conservationist purchased the land when it became available and held it until the NPS could purchase it. The number one acquisition priority for the OWSR is a tract at Obed Junction

Evacuation Trails:

Matt reviewed Chota's "Obed Emergency Exit Routes" and mentioned possible alternate routes due mainly to changes that have occurred on the OWSR. He hopes to create a field-tested revision of the escape routes later and share it with the clubs. A couple of the items mentioned were:

Daddy's Creek, DBT to Obed Junction. The Cumberland Trail now runs along river right. You can use it to hike back upstream along the river to your car.

Clear Creek, Below Focus Falls. On river left, don't turn right to go downstream of Focus Falls, the portion of the climbers trail that ascended to the canyon rim is no longer there. You will have to turn left and go upstream.

Special Note: Hydrilla, an invasive water plant probably released from aquariums, has been found in Daddy's Creek and the Obed. It's not in Clear Creek—yet. It spreads easily from small pieces and can become very dense. Please be careful at put ins and take outs by checking your gear and removing and trashing pieces of Hydrilla.

EAST TENNESSEE WHITEWATER CLUB BEGINNER KAYAK CLINIC

COURSE DESCRIPTION

The East Tennessee Whitewater Club offers an intensive one-week course for beginner kayakers. The purpose of the clinic is to teach basic whitewater techniques and safety. Whitewater experience is not required but individuals should be comfortable in water and able to swim.

DATES: Monday, June 1 through Saturday, June 6, 2009 **HOURS, MEETING PLACES, AND ACTIVITIES:**

MONDAY: 6:00 P.M. until 9:00 P.M.

Personal in-the-water instruction on kayaking techniques, including paddling strokes,

SATURDAY: River trip location, meeting place and time to be announced Friday.

Supervised trip on local whitewater river and party afterwards.

FEES: The cost of the clinic is \$60 (Includes 6-month club membership).

EQUIPMENT: Each student is responsible for furnishing all of their own equipment. Required equipment is: kayak with flotation, spray skirt, life vest, paddle, and helmet. Nose clips are recommended.

Some equipment may be available from the club on a first come basis with a \$15 use fee and a \$40 deposit. Note: Please write a separate check for the deposit.

- 1. Canoeing, kayaking, or rafting, particularly on whitewater rivers, exposes the participants to various safety hazards, including but not limited to, water hazards (boulders, undercut rocks, trees, strainers, water formations such as water falls, holes, keepers, hydraulics, and other obstacles), swimming in turbulent water, using paddling equipment, accidents or illness in remote places without medical facilities, and travel in a vehicle not driven by me.
- 2. No one but I am responsible for my safety when I choose to paddle a particular river or a particular rapid.
- 3. I further understand that I have no legal duty to assist others, nor does anyone else have a legal duty to render such assistance to me. I certify that I am in good physical condition, that I can swim, and that I have no physical defects or injuries that would prevent me from participating in this activity. I fully understand and agree that, when I participate in canoeing, kayaking, or rafting, there is always the possibility of unknown, uncontrollable dangers and accidental or other physical injury and death. I know I can be killed, and I willingly assume the risks referred to in Paragraph 1 and elsewhere in this release.

Therefore, in consideration for granting me the right to join and participate in ETWC activities, and intending to be legally bound, I hereby release, waive and discharge my right to sue ETWC, its trip coordinators, instructors, leaders, officers, directors, representatives, agents, employees, and affiliates, and also any landowner or governmental unit which may allow ETWC to use its property, for any and all loss or damage on account of injury to my person or property or on account of my death, which may occur during, in preparation for, or in transit to or from an ETWC activity.

I further understand that ETWC carries no insurance for the protection of participants in whitewater activities, and any insurance coverage existing with respect to ETWC shall not alter the terms of this waiver nor impose any liability on ETWC.

This waiver applies only to acts or omissions of ordinary negligence and to any deliberate act intended to promote my safety or well being.

This waiver is signed by me in the interest of permitting ETWC to exist and to serve the paddling community, and to enable me and my fellow paddlers to feel free to donate their services to improving the sport and to help in training those less skilled in the sport without fear of liability.
