#### **Trip Reports**

The August 7 beginner trip had a huge turnout of 28 people: 18 kayaks, 3 tandem canoes, 2 C-1s, and a tandem siton- top! Several of us met at the Mayfield dairy in Athens for the traditional ice cream treat before the river trip. The price of the cones has gone up but where else can you get three scoops of ice cream for the price of one? We met the rest of the group at the take out before heading up to the top. We split up into two large groups with Billy Bob in C-1 leading Pete Dolan & Cameron Driskill, Joe & Kelly Pyle, and David & Christopher Tate in tandem canoe; and Sherrie Liafsha, Ted Buel, Natasha & Nicole Tate and Mary Misulich in kayaks. Ariana and I led Mike Machen, Craig & Gillian Davis, Alvaro Mayagoitia, Greg Williams, Rick Zingg, Mark Koci, Theresa Joyner, Paul Wolfe, Cody Trigg, and Sandy Floyd in kayaks; Josh Golliher in C-1; and Jessica and Mike Weaver in the tandem sit-on-top. Billy Bob's group had all the kids with a great match up of 9-year-olds who looked like they were competing to see who worked the hardest in tandem canoes with their dads. I think Natasha and Nicole enjoyed paddling with someone near their own age since Cameron was only a couple of years older. Pete said Cameron also seemed to enjoy being on the river more and worked harder than usual. Their group was running ahead of us but we all met up at lunch for a short time after Thread the Needle at the river right picnic tables. We were a little slow going down the river with 15 boats in our group. We debated splitting up but no one else felt they knew the Hiwassee well enough to lead. Kudos and thank you's go to Cody and Rick who assisted with almost all our rescues. Cody always seemed to know who would need help and was able to react quickly. Rick had to use his rescue tether for one long rescue and was a big help setting up as safety in several places ahead of time. Josh, who was in his C-1 and favoring a bad shoulder, helped by leading several times in rapids when our large group just naturally broke up into smaller groups. Mark ended up helping Jessica and Mike a lot in their tandem sit-on-top. It really was difficult to maneuver and wore them out. Sandy, who had only been on a lake in a kayak, was a very fast learner and quickly adjusted to paddling in current. A big part of Sandy's doing ok on the river was Cody's great job of teaching her and telling her what to do. She even helped Cody with a rescue by grabbing Gillian's paddle that he threw to her. Good reflexes! Ariana finished up that rescue by giving up her paddle and hand paddling down to where Gillian could join up with her own paddle. Mike, who took the clinic this year, flipped at the Needles and came up with a snappy combat roll. He seemed to take it all in stride but we were excited for him. Gillian and Craig, who also took the clinic this year, were in their own boats courtesy of Jim Lyon who has moved to Colorado and donated his spare boats to the club. Theresa did great even though she had not paddled in almost two years and was in a new kayak (also from Jim). She went from paddling apprehensively to actively looking for the best lines and going for it. Alvaro (also in this year's clinic), Paul, and Greg all seemed to have no trouble even though none of them had paddled lately. Ariana says she enjoyed the side surfing hole at Stair Steps being empty so we could play (it's always busy during the clinic). Billy Bob's group spent some extra time swimming and relaxing at Lost Creek where he says Kelly "durned near drowned him". We weren't too far behind them at the take out. On the way home, we split up into two groups again, those who wanted to eat in Etowah at Tony's and those who wanted to eat at the Mexican place. We were all pretty tired puppies but the Hiwassee was a great place to be on a hot summer day.

#### 2010 - 2011 Winter Roll Practice

The City of Oak Ridge has new requirements for renting the indoor pool that will affect ETWC's roll practice.

- 1) All groups that use the pool are required to have a certified lifeguard in the pool area when the pool is in use.
- 2) If your group does not have a certified lifeguard, the city may be able to provide a lifeguard at an additional cost of \$15 per hour.
- 3) All rental groups will continue to have all participants/parents sign a City of Oak Ridge Hold Harmless Release and turn the release in to the Recreation and Parks Department.
- 4) Liability insurance naming the City of Oak Ridge as an additional insured party may be required. (If we use the city lifeguard, the insurance is provided by the city. If we provide our own lifeguard we have to purchase liability insurance.)

Our Friday night pool sessions, 8:30 to 10:00 pm, cost \$33.75 (\$22.50/hour). In the past we charged \$3.00/person and had to average 11 persons per session to cover the pool cost for the year. We have pretty much broken even on the cost for the last few years. If we use the city life guard our cost will be \$56.25 per session and we will have to charge \$5.00/person based on averaging slightly more than 11 persons per session. We will still need a roll practice host to run the session but they will not have lifeguard responsibilities.

If we provide our own life guard we will have to find someone who is trained and willing to be at every roll practice. We will also have to purchase insurance. Insurance is available through the American Canoe Association (ACA) or Paddle America Club. ACA Insurance requires attendees be an ACA member or pay an additional \$5.00 (\$10.00 total/session) to be covered by the insurance. We would have to submit fees, report forms, and waivers to ACA. Paddle America Club insurance would cost us \$225 for a membership which would provide insurance for all our events. In addition to the membership cost, we would have to pay an extra fee of \$20 to add the City of Oak Ridge as an additional insured party. It appears that using the city life guard and increasing the charge to \$5.00/ person is the simplest solution for continued ETWC roll practice at the indoor pool.

#### A letter from Warren Devine

Do you read the TCWP Newsletter (see then attached letter from TCWP President Jimmy Groton)? They recently were able to buy a 19-acre inholding on Clear Creek for eventual donation to the Park (The Park was unable to buy it fast enough to keep it from developers). Now TCWP needs to replenish the account they used for the purchase (\$40,000) in order to be able to do this again.

A number of years ago ETWC voted to contribute \$1,000 toward the purchase of an inholding at Nemo. That turned out to be unnecessary. I assume we still have the money.

I would like to suggest ETWC "re-program" this contribution to the TCWP "Obed Land Purchase Fund." I further suggest we do so in the memory of Patrick Martin. I can't think of anything he would like his name attached to better than this.

If we are feeling particularly flush, we could add to this amount in the names of three other Obed/Clear Creek lovers--Jim Stevenson, Ron Cook, and Bob Williams. Ron used to say "Land is the most valuable thing--they aren't making any more of it!"

Taking Care of Wild Places

#### Dear TCWP Friend:

Help TCWP save Obed land from sale to developers!

Many of us have had the good fortune to visit the Obed Wild and Scenic River (OWSR) to canoe, kayak, hike, swim, fish, picnic, or just enjoy the spectacular scenery. You may have assumed that those magnificent bluffs that make up the river gorges were protected from development by the National Park Service.

Unfortunately, that is not the case. Roughly 20% of the land within the authorized Park boundary is still in private hands, with the pristine viewshed unprotected. In the past few years, several land sales have threatened to spoil this viewshed.

The Park Service doesn't typically have ready access to funds when opportunities arise to purchase authorized land from willing sellers. Because timing for such acquisitions is often critical, Tennessee Citizens for Wilderness Planning (TCWP) has established funds so that we may act quickly to purchase land within the Park boundary when it comes up for sale.

When the Park Service was unable to respond in time, TCWP recently purchased 18+ Obed acres that contain a 70-foot waterfall on a tributary to Clear Creek. We will hold and protect this land until the Park Service can acquire the funds and complete all the administrative steps needed to reimburse TCWP and take title of the land.

Meanwhile, TCWP is asking for your help to replenish our funds so that we will be ready for the next opportunity to protect another parcel of this incredible resource! Please join us in our efforts to preserve this unique wild treasure.

Protecting the Obed was the main objective behind TCWP's formation, and it has remained a major goal for us for more than 40 years. Even if you have not been privileged to enjoy the pristine viewshed of this unique wild and scenic river -- whether from the bluffs, trails, or on the river - we hope you have come to realize that this is an unparalleled treasure that must be preserved. Your contribution to the TCWP OWSR land fund is a gift to all its visitors now and for generations to come. TCWP plans to use your dollars over and over as we acquire land then transfer it to the Park Service. Our immediate goal is to raise \$40,000 by December of this year. Please send your contribution today, since another Obed tract may go on the market at any time!
