Volunteers needed for the Morgan County 6th Graders Program

The National Park Service's Obed Wild & Scenic River unit is again sponsoring their Morgan County 6th Graders program this May. The program was the subject of the last ETWC meeting, and was presented by NPS Ranger Veronica Greear. This will be the 8th year for this award winning NPS program. In the program, students from each of the 6th grade classes in Morgan County go to Lilly Bridge to do rock climbing and boating. ETWC has assisted the NPS in gathering volunteers for the water portion of the program, and we are again looking for boaters. This year's program will run on weekdays between May 13 and May 22, with May 22 as a potential rain date.

Each day volunteers are needed around 8:30 to help the NPS Rangers unload boats and gear before the bus arrives at Lilly Bridge around 9 a.m. with students from one school.

The students are divided into two groups, and one group goes rock climbing while the other group goes to the water program. We help the NPS Rangers fit helmets and PFDs on the students before they carry the NPS-provided boats and paddles to a pool below Lilly Bridge. The first activity is usually the popular "Critters in the Creek" program by NPS personnel that involves the students capturing and identifying the aquatic life in Clear Creek - and thus proving how unpolluted the water is.

After the Critters program, we help put the students into the NPS boats before we get into our own boats and gear to paddle with them in the pool. We limit instruction to the minimum required for safety - the emphasis is for the students to have FUN. If time and weather permits, we let the students go for a brief swim in the upstream end of the pool. Each group is accompanied by at least one teacher who can handle any discipline issues - but we have had none.

Around noon we break for lunch, and then switch groups and repeat the activities. When we finish, the students carry the boats and paddles back up the hill before leaving to return to school around 3 p.m. We then assist the NPS Rangers in sorting and loading their equipment onto their trucks and trailer.

If you have can spare a day or more, please consider volunteering for this activity. You will be very impressed by the 6th Graders and teachers of Morgan County, and every session has been fun for all.

Obed Wild and Scenic River Clean-up March 30.

WARTBURG, Tennessee: On Saturday, March 30th, the Obed Wild and Scenic River and Tennessee Citizens for Wilderness Planning are working together to host a riverbased cleanup of the section of the Obed River between the Devil's Breakfast Table and Nemo. This eleven mile section of stream is one of the most dramatic in the entire park, featuring towering cliffs and a sense of remoteness rarely found in today's world. Experienced whitewater paddlers are welcome to join in the cleanup but must provide their own whitewater boat, personal floatation device, helmet and appropriate river attire. Paddlers should be highly proficient in Class III/IV whitewater. Individuals wishing to assist with the cleanup should meet at the Obed Wild and Scenic River Visitor Center located at 208 North Maiden Street in Wartburg, Tennessee, at 9 a.m. (ET) on March 30th. Participants should be prepared to use their own vehicles to shuttle to the take-out point at Nemo and drive to the put-in location at the Devil's Breakfast Table. The river trip is subject to cancellation due to weather and river levels. Although rapidly changing conditions could necessitate cancelling the river trip on the morning of the event, a tentative go-no-go decision will be made by 4 p.m. on the afternoon of Friday, March 29th. If the river trip is cancelled, a land-based cleanup will take place near Nemo Day Use Area. Participants can obtain status updates via the park's Facebook page, www.facebook.com/ObedNPS . Obed Chief Ranger Matt Hudson recognized

If you've paddled any of the Obed WSR streams, or climbed the river side cliffs, or visited the visitor center in Wartburg, odds are you've crossed paths with Obed WSR Chief Ranger Matt Hudson. In fact ETWC has worked with Matt and his staff on several initiatives and activities over the years. Matt was recognized in the National Parks Magazine by the National Parks Conservation Association. The following is an excerpt.

A Wish To Live Deliberately

Matt Hudson is climbing — maybe better described as hanging — from a massive horizontal shelf of East Tennessee sandstone some 50 feet above a cluster of sixth-graders. The students crane their necks as they follow his Spiderman-like movements up the sheer rock face and out underneath it. Below the group, the rushing Clear Creek works its way through a deep gorge carved into this hemlock forest on the Cumberland Plateau.

"Ready?" Hudson asks of his belayer. "Falling." And fall he does, releasing his hold on the rock and dropping toward the group of wide-eyed middle schoolers. The rope Hudson is attached to stretches out until it's taut, suspending him, as he bounces lightly, about 10 feet above the heads of his incredulous audience. He has their attention.

As a boy in central Tennessee, Hudson remembers looking east and gazing at the Cumberland Plateau. "My heart has always been on the Plateau," he says. An admittedly poor high school student, Hudson collected himself enough to gain admittance to a college near his home. After graduation, he decided to take the LSAT just to see how he'd do. Pretty well, it turned out. Hudson earned a law degree from Harvard University, where he spent his spare time in nearby Walden Woods and immersed himself in the writings of Henry David Thoreau and Thomas Merton. During and immediately after law school, he traveled widely, including a 40-day solo canoe journey down the Yukon River. Eventually, he moved to Nashville and worked for a law

firm, but after a short time, he left. To explain why, he recites this passage from Thoreau's "Walden: or, Life In The Woods": "I went to the woods because I wished to live deliberately, to front only the essential facts of life, and see if I could not learn what it had to teach, and not, when I came to die, discover that I had not lived."

Today Hudson is the chief ranger at Obed Wild and Scenic River, a series of deep gorges cut into the Cumberland Plateau. At the bottom, framed by sheer sandstone bluffs that attract serious rock climbers, lies what some paddlers describe as the finest white water in the East. An expert climber and paddler himself, Hudson brings all the sixth-graders in this rural county into the gorge each year for a rock climbing and river paddling experience. He wants to instill in them some of what drew him away from a career in the skyscraper canyons of Nashville back to his beloved Plateau. Hudson hopes they will understand and appreciate the remote, extraordinary place where they live. "It's an intimate beauty," Hudson says. "The Obed is full of hidden places — things you would not expect. You discover things here, close up."

Program: Our Presenter was Veronica Greear, a Ranger with the NPS Obed Wild and Scenic River who discussed the upcoming "National Park in your Backyard" program coming up in May. This will be the 8th Year of the program and it has been extremely successful. The program has become something that the kids look forward to as they enter 6th grade and is having a major impact on their perception of the park. Veronica described how more local people are developing an interest in the park, and vandalism, destruction, and littering in the park have dropped significantly since the kids have been interacting with the Rangers and our volunteers instilling an interest in the park in these kids.

There is a different wrinkle in this years program. In light of the success of this program, the Outdoor Foundation in coordination with the NPS has awarded ETWC a \$7,500 grant to support this activity. ETWC will use this grant to work with and support the Outdoor Foundation to provide for the program needs including equipment, supplies, and bus transportation for the 6th graders. ETWC is required to match the grant money with equivalent volunteer hours.

In addittion to the 6th graders this program now includes several 4th grade classes from Morgan County and Knoxville.
